

RESOLUTION 08-2023

A RESOLUTION OF THE CITY COMMISSION OF CITY OF SAN ANTONIO FLORIDA APPROVING THE CITY CLERK'S RECOMMENDATION AND REQUEST TO AMEND THE FY 2022-2023 BUDGET; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Clerk is authorized and directed by the City Charter to prepare and submit the budget to the City Commission, and to “keep the Commission fully advised as to the financial condition and future needs of the city, and shall make such recommendations to the Commission concerning the affairs of the city as the Clerk deems appropriate”; and,

WHEREAS, the City Clerk recommends and requests that the Fiscal Year 2022-2023 Budget be amended as provided.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF CITY OF SAN ANTONIO, FLORIDA in a public meeting assembled this 20th day of September, 2023:

2. Increase the Capital Purchases - Parks budget line item by \$4,000.00
3. Increase the Lake Project Expense budget line item by \$4,000.00
4. Increase the Capital Purchase budget line item by \$9,000.00
5. Decrease the Reserves Contingency line item by \$23,000.00
