 - 1. Woods Pepperman of Palm St. asked what will happen to the current city hall building. Public Works Director Morrow advised it would be remodeled next and still used as the City Clerk's office and for records storage.
 - 2. Janice Davis of Palm St. suggested letting people know this is paid by a grant. Commissioner Huckabee recommended signage during construction to show who is funding it and thanking them for funding the project.
 - 3. Commissioner Huckabee asked about the next steps in the process. Public Works Director Morrow advised the bid packet would need to be created then approved by the commission next.
- D. Mayor Vogel asked that the public continue to keep him accountable.

4. ATTORNEY'S REPORT:

- A. There is a bill being introduced at the current legislative session which would remove the 25% surcharge to outside city limits water connections starting July 1, if passed. Attorney Buhr recommended that the city begin planning for this. The commission asked that staff provide information on how this would affect the city.
 - 1. Janice Davis asked whether the city could stop providing water to out of city limits properties. Water Clerk Plazewski advised of existing moratorium on new outside connections but having no right to revoke water service to current customers.
