2. PUBLIC COMMENT:

 - 2. Attorney Buhr advised the city to evaluate records to determine who is responsible for stormwater management.
 - 3. Mayor Vogel advised that the city would do further research and contact the HOA to schedule a meeting to resolve the matter.

B. Dick Gates of Pasco Rd. asked for an update on Curley Rd. and the status on the speed bumps installation on Antonio Way. The commission had no recent update on the Curley Rd. closure and the temporary speed bumps for Antonio Way were in the works.

3. MAYOR'S REPORT:

- A. City staff is working with Senator Burgess and Representative Maggard's offices to obtain funding for the water tower replacement.
- B. Commissioner Schrader spoke with all county commissioners regarding the Orange Belt Trail city opposition letter. Mayor Vogel attended the county commission meeting and presented the city concerns over the trail routes. The city opposition to the trail route was also published in a Tampa Bay Times article.
- C. Commissioner Schrader's resignation would take effect November 22. The vacancy would be opened for applications November 22 to December 8. The special meeting to interview candidates would take place December 11th at 6:00 P.M.
