# 2. PUBLIC COMMENT:

A. Frank Hill of Pennsylvania Avenue asked if the commission would reconsider allowing cargo containers in the city. Attorney Buhr recommended reaching out to the planning consultants. Commissioner Vogel would get more information from the planning consultants regarding changing the code.

# 3. MAYOR'S REPORT:

- A. Lee Isham, representative from Tampa Electric Company, informed the commission that four new streetlights within city limits are proposed in the FDOT roundabout project at the intersection of County Road 52, College Avenue, and Pompanic Street. Estimated cost for the 20-year lease would be a fixed cost of \$58.12 per month per light pole in addition to the variable energy cost. TECO wants to know who will pay for these lights and asked that the city provide a letter of authorization if assuming the responsibility of cost. Mayor Anderson asked that TECO provide a proposal for the June meeting.
- B. A bay door is broken at the Public Works building and repairs are estimated to cost below \$4,000.
