AN ORDINANCE AMENDING THE DISTRICT BOUNDARIES OF THE ZONING MAP OF SAN ANTONIO, FLORIDA, AS ENACTED BY CHAPTER 82, SAN ANTONIO CODE, SO AS TO CHANGE THE ZONING CLASSIFICATION OF A PARCEL OF LAND TOTALING 10.10 ACRES LOCATED ON THE WEST SIDE OF ANTONIO WAY APPROXIMATELY 1,000 FEET NORTH OF PASCO ROAD (PARCEL 35-24-20-0000-02500-0000), FROM PASCO COUNTY AGRICULTURAL/RESIDENTIAL (AR) TO PLANNED UNIT DEVELOPMENT (PUD); PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

Ordinance proposes the zoning amendment of a 10.10-acre parcel of land from Pasco County Agricultural/Residential (AR) to Planned Unit Development (PUD).
