3. ORDINANCE 03-2025 (SECOND READING)

AN ORDINANCE AMENDING THE DISTRICT BOUNDARIES OF THE ZONING MAP OF SAN ANTONIO, FLORIDA, AS ENACTED BY CHAPTER 82, SAN ANTONIO CODE, SO AS TO CHANGE THE ZONING CLASSIFICATION OF A PARCEL OF LAND TOTALING 18.85 ACRES LOCATED AT NORTHWEST CORNER OF THE INTERSECTION OF DARBY ROAD AND CURLEY ROAD (PARCEL ID 35-24-20-0000-00700-0010), FROM RESIDENTIAL DWELLING (R-2) TO PLANNED UNIT DEVELOPMENT (PUD); PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

- a. Planning consultant, Marisa Barmby, presented the staff report for Ordinance 03-2025.
- b. Public hearing was opened
- c. Mayor Vogel clarified that the project includes single family residences only. The petitioner will be required to complete a traffic study and get approval from Pasco County for access to adjacent roads.
- d. Attorney Buhr administered oaths to public commentors.
- e. Randal Manning of Curley Road pointed out inconsistencies with the acreage presented in the report and the acreage listed by the Property Appraiser.
 - i. Marisa Barmby recommended resolving this issue before moving to vote on a second reading.
- f. Randall Manning was concerned about the density, stormwater drainage, and impact to the roads.
- g. Richard Crocker of Wesley Way was concerned about septic systems being placed close to his well and asked for additional buffer requirements.
- h. Lester Pittman of Wesley Way was concerned with the septic systems, and traffic and school impact.
- i. Mike Riley of Wesley Way was concerned over the density.
 - i. Mayor Vogel clarified that the zoning code allowed for no more than two units per acre.
- j. Petitioner Sebring Sierra stated that the PUD designation would allow for neighborhood infrastructure. He would follow all state regulations for traffic studies, stormwater runoff, and septic systems.
- k. Marisa Barmby explained the different processes between R-2 and PUD zoning designations. Buffers, setbacks, parking requirements, and square footage would need to be included as PUD conditions. Florida Statutes do not allow the city to regulate the design of the home itself.
- I. Charles Carey of Wards Court asked about setback requirements.
- m. The petitioner would schedule a meeting with the city to resolve lasting city and citizen concerns prior to voting on a second reading.
- n. Public hearing was closed.
