 - b. Anthony Cicanese questioned the value of this type of business for residents and was concerned over the impacted wetlands.
 - i. The proposed developer explained that the design presented would maintain stormwater onsite with a pond in the back of the property and impacts to roads and schools would be minimal.
 - c. Susan Minsberg of Dunne Road asked about chemicals washing into the retention pond and the harm to wildlife.
 - d. Crystal Clerico of Summerfield Way mentioned residents using sheds on their property for storage.
